Must be a parent or guardian accompanying the child. If someone else brings the child to clinic, must have a proxy form signed. You may call the Wisner office at 402-529-3513 to obtain the proper forms. There is suggested donation of \$13.50 for a single vaccination, or a suggested donation of \$20.00 per visit. No one will be denied vaccinations for inability to pay.

Immunization records are required at each clinic visit.

It is important to follow up with your family physician for well baby or childhood check ups on a regular schedule.
